Assessment and Statement

Bioinvent has carefully answered the questions in the self-declaration and provided documents that support these answers. Bioinvent has described its value chain, performed a stakeholder analysis and a materiality analysis based on the ISO 26000 standard, and based on selected goals and sub-goals from the Sustainable Development Goals (SDGs). The goals have been compiled in an 'action plan of priority goals'. Linked to this is a business plan that includes an external SWOT analysis. BioInvent's sustainability methodology is anchored in a double materiality approach and VSME reporting (Basic and Comprehensive modules)

Throughout the year, Bioinvent intensified its commitment to the Agenda 2030, emphasizing the ongoing sustainability journey. This includes employee well-being initiatives, staff education on sustainability, and setting specific goals to reduce its environmental impact in 2026. Their main priorities are enabling manufacturing control and reduced external supply risk, practical circular economy practices such as reuse/refurbishment of equipment, waste sorting and use of specialist waste handlers for hazardous waste. The organization has also begun a Sope 3 analysis as part of 2025/2026 planning.

There is clear management and division of responsibilities in the business. A high degree of transparency prevails and good business ethical behavior can be discerned throughout the business. Bioinvent shows respect and sensitivity to the interests of stakeholders.

VERIFY Agency of Sweden AB has verified all levels of activities that the organization states in the sustainability declaration. VERIFY Agency of Sweden AB has performed the verification through interviews with the organization's staff and through a sampling of the documentation that the organization refers to in the self-declaration and in the management of its sustainability work, such as policies, business routines, meeting planning, analyses, assessments, minutes, surveys, communication efforts, and training. An on-site audit was also performed.
